

# **PRESIDENT'S REPORT**

Dr. Pamela Lau reported on the following:

## 1. Major events

Thanked those who were able to join at the AGCO Training Center ribbon cutting and the holiday reception – both of which were held on December 3.

The strong showing of our board clearly communicated the college's commitment to supporting private-public partnerships as a major strategy to developing the skilled workforce pipeline. AGCO Corporation sent out our joint press release on the ribbon cutting. There were more than 100 news stories on the occasion. Trustees were gifted a miniature replica of a Fendt or Massey Ferguson tractor as a souvenir to remember the occasion and partnership.

# 2. Enrollments for Spring 2025

Final exams concluded last Friday on Dec. 13, ending the fall semester. As of this morning (December 18), enrollments for spring 2025 are 6.0% in the positive compared to the same time period a year ago, despite a clean-out drop for non-payment on Monday (December 16). Student Services staff worked hard to contact and re-enroll students who still plan on attending Parkland in the spring semester.

#### 3. Former trustee Lin Warfel honored

Former Trustee Lin Warfel was honored by the Illinois Farm Bureau with the prestigious Eagle Award for Excellence for his unwavering dedication and advocacy for agriculture in general and Ag in the Classroom programming in particular. His long list of recognized achievements includes his longtime service as a Parkland College board member. Parkland is privileged to have had Trustee Warfel serve in a board leadership role. We continue to build upon his legacy.

## **FINANCIAL STATEMENTS**

The financial statements for November reflect the results of operations of the College for the first five months of fiscal year 2025. The revised budget estimates indicate that expenses will exceed revenues by \$3,799,356.

The key factors for the College's operating results in FY2025 will be tuition & fee revenues (enrollment), CPPRT revenues, and self-funded health claims' expenses and planned fund balance spending.

The FY2025 audited beginning operating fund balance is \$44.2M. This amount is 62% of current budgeted operating expenditures.

TheFY2025 final budget projected a \$3,660,338 deficit.

The FY2025 College tentative budget was lodged in July.

The FY2025 College final budget was presented in September.

The FY2024 College audit was presented in October.

The TY2024 tax levy estimated amounts necessary were presented in October.

Administration recommended purchasing equipment for the Construction program from Grainger, Lake Forest, IL, for a total cost of \$25,653.76. This purchase utilizes the Illinois Public Higher Education Cooperative (IPHEC) agreement. These items are exempt from formal bid requirements per the Illinois Public Community College Act section 805/3-27.1 (k) contracts for goods or services procured from another governmental agency. Board authorization is requested since the cost exceeds \$20,000. Funds are available from the Perkins grant.

It was moved by Ms. Green and seconded by Mr. Trimble to approve the purchase of equipment for the Construction program from Grainger, Lake Forest, IL, for a total cost of \$25,653.76.

# EXEMPT PURCHASE – DESIGN AND CONSTRUCTION OF MOBILE CAREER ENGAGEMENT UNIT

As part of Parkland College's Career Engagement Priority and the creation of a Department of Career and Community Engagement aimed at increasing awareness of career opportunities and educational pathways, we are contracting for the design and construction of a customized fifth-wheel trailer to serve as a mobile career exploration lab and district-wide recruitment space.

After consultation with other organizations and educational institutions that have developed similar mobile units, it was determined that limited vendors would customize and build vehicles for such purposes. Accessibility with a chair lift and the ability to include bump-outs to expand the width of the interior space is essential. Standard RVs and box trailers are not accessible nor suited to the needed customizations. Upon determining the minimum needs for the trailer, we opened discussions with the few vendors providing services in this realm.

Proposals were requested from the following vendors:

Mobile Marketing Solutions, Inc., dba Brewco Marketing Group of Central City, KY, in conjunction with Triune and RBD of Elkhart, IN, work as a consortium to design, build the frame, and custom build the trailer and interior to be accessible and fully functional with power and internet. They provided preliminary designs of fully customized and accessible plans as needed for a cost of \$227,500, including delivery and training. Brewco indicates that the quote is dependent on the cost of materials at build time, so we have added a contingency of a little over 18% in case of needed modifications.

Luxe Luxury Vehicles of Elkhart, IN – unable to customize to specifications needed for accessibility and chose not to provide a quote.

Farber Specialty Vehicles in Reynoldsburg, OH – chose not to respond.

- 4. Effectively market and promote the college, its programs, and services to raise awareness of opportunities for social and economic mobility and career advancement; increase awareness of the college's priorities among key stakeholders, including policymakers.

Administration recommended approval of the contract for the design and construction of a fifth-wheel career engagement trailer from Mobile Marketing Solutions, Inc., dba Brewco Marketing Group, Central, KY, for a total cost not to exceed \$270,000. This item is exempt from formal bid requirement per the Illinois Community College Act, Section 805/3-27.1 (l) contracts for goods or services which are economically procurable from only one source, such as for the purchase of magazines, books, periodicals, pamphlets and reports, and for utility services, such as water, light, heat, telephone or telegraph. Board authorization is requested since the cost exceeds \$20,000. Funds are available from the ICCB Taking Back the Trades! Grant for this purchase.

Dr. Sutton noted that the unit will be used to take out to schools and community events to highlight our different career programs and for registration, advising, and assessment testing. The design of the vehicle is accessible and has a lift to make it functional. It will be pulled by a truck that will be purchased with grant funds.

Dr. Lau thanked Dr. Sutton for her work obtaining the ICCB funding. We received word today that Parkland received grant funds again for the third year in a row.

It was moved by Dr. Banks and seconded by Ms. Ragsdale to approve the contract for design and construction of a mobile career exploration fifth-wheel trailer from Mobile Marketing Solutions, Inc., dba Brewco Marketing Group, Central, KY, for a total cost not to exceed \$270,000.

The motion carried by the following vote: AYES—Ayers, Banks, Clem, Green, Ragsdale, Trimble, Campbell (Advisory Vote), Voyles; NAYS—None.

# <u>PARKLAND CHILD DEVELOPMENT CENTER UPDATE AND TUITION</u> INCREASE

In the annual review of the Parkland Child Development Center (PCDC) educational program, Administration recommends increasing the daily fees of PCDC. The incremental rate increases are intended to increase PCDC revenues to ensure sustainability of the program and thus decreasing operating funds transfer required to balance the PCDC budget.

Administration also recommended the continuation of the 8% discount for Parkland employees and students, as this has also garnered several new enrollments. The team has increased the share of Parkland student families within the center to 64% of the children enrolled, with 10% employee families, and 23% community families. Additionally, 67% qualify for free or reduced lunch under ISBE guidelines.

The proposed tiers are comparable to other childcare centers in Champaign-Urbana, and CDC leadership has gathered updated tuition rates from area centers for benchmarking purposes. The new rates, as recommended, would take effect January 1, 2025. Rates for each tier have increased \$1.50 per day to keep pace with area centers.

## EXEMPT PURCHASE – CLUB EUROPA

Based on responses to a community survey, Parkland College Community Education is planning a 12-night customized Journey to Rome, Assisi, and Tuscany area for 20-29 travelers in Fall 2025. It includes superior tourist or moderate first-class hotels, meals, deluxe motorcoach services, airport transfers, licensed local guides, river cruises, local taxes, and gratuities for local guides and coach drivers.

Parkland College Community Education works with Club Europa, a tour designer and operator specializing in customized group travel to purchase group travel tours for community members including transportation, accommodations, private and public tours, guides, gratuity, and some meals. Club Europa, a leader in international travel to and through Europe, was founded in 1959 and boasts fifty percent European senior staff with travel experience. Their on-site staff of tour directors, local guides, assistants, and chauffeurs are carefully chosen and trained by Club Europa, guaranteeing the highest quality professional service.

Community Education has developed a reputable and long-standing partnership with Club Europa. They are knowledgeable about our audience, experts in European travel, and have designed high-quality European tours for our community for more than 15 years. Community Education regularly evaluates the program and services and has continued to partner with Club Europa because their programs and services meet or exceed our customers' expectations.

This purchase relates to the following strategic goal:

**Goal C: Enrich the Community:** Parkland College will work collaboratively to enrich the District 505 community.

- 3. Provide and develop relevant credit and non-credit lifelong learning opportunities for District 505, with a particular focus on engaging with historically underserved communities.
- 5. Maintain an open door for the community to visit campus and engage in enriching programs, events, and experiences.

Administration recommends purchasing the group tour service from Club Europa, Urbana, IL, for a total cost not to exceed \$145,000. Items are exempt from formal bid requirements per the Illinois Public Community College Purchasing Act section 805/3-27.1 (a) contracts for the services of individuals possessing a high degree of professional skill where the ability or fitness of the individual plays an important part. Board authorization is requested since the cost exceeds \$20,000. Funds are available from the FY2026 Community Education budget for this purchase.

## IX. BUSINESS & FINANCE—Item E

## BOARD APPROVAL - PHS - REPLACE P-WING BOILER

At the September 2024 Board of Trustees meeting, Protection, Health, and Safety funds were approved to replace the boiler in the P-Wing/Gymnasium. The boiler is original to the building and is at the end of its useful life. Maintenance and repairs have become increasingly frequent and costly. The boiler will be replaced with a modern, high-efficiency condensing boiler, which will provide the gymnasium with reliable heating well into the future.

A legal bid notice was placed in the News-Gazette for general contractors to replace the P-Wing boiler and upgrade the domestic hot water system. The bid was also posted in the Eastern Engineering Plan Room, a repository for contractors accessing bid notices when searching for work.

A global leader in biofermentation is seeking a suitable location to build a \$750 million corn wet milling and biofermentation manufacturing plant to produce amino acids for livestock feed. The main processing plant would be supported by auxiliary unit operations such as grain handling, combined power & heat, water treatment, wastewater treatment, and finished product operations including loading, packaging, and warehousing. The company intends to buy and process locally grown corn and projects employing 240 individuals at the plant.

Douglas County EDC has been actively working with the State of Illinois DCEO to attract this company to develop this manufacturing facility on a brownfield property in their County.

Douglas County's EDC proposed property assessment agreement presents an economic incentive to the manufacturer in their site selection. The Agreement establishes a value of the Subject Property for purposes of calculating real estate taxes under this Agreement. A Market Value Estimate for the Subject Property was commissioned by the Douglas County Supervisor of Assessments and conducted by Vanguard Appraisals in 2024 (the "Market Value Estimate"). The Agreement, if approved by all involved units of local government, runs from Tax Year 2025 through Tax Year 2057.

WHEREAS, the Company and the Taxing Bodies have set out in writing their agreement, and said agreement is attached hereto and incorporated fully herein, (the "Property Assessment Agreement"), and this body now wishes to take action regarding said Property Assessment Agreement; and

**THAT** it is necessary, useful and desirable to establish the future tax obligations of the Company with respect to the Subject Property; and,

## PROPERTY ASSESSMENT AGREEMENT FOR THE PROPERTY LOCATED AT 625 E US HIGHWAY 36, TUSCOLA, ILLINOIS

THIS PROPERTY ASSESSMENT AGREEMENT (this "Agreement") is made and entered into effective as of December 16, 2024 (the "Effective Date"), but actually executed by each of the undersigned units of local government and local officials (each a "party", together "parties") on the dates set forth beneath the respective signatures of their duly authorized officers below.

## <u>WITNESSETH</u>

WHEREAS, there exist ten (10) parcels of real property commonly known as 625 E. U.S. Highway 36 located west of the City of Tuscola, in Douglas County, State of Illinois 61953 (PINs: 05-01-36-100-001, 05-01-36-100-010, 05-01-36-100-011, 05-01-36-200-007, 05-01-36-200-009, 05-01-36-200-010, 05-01-36-403-006, 09-02-30-300-002, 09-02-31-100-005, and 09-02-31-300-005,) (the "Subject Property");

WHEREAS, the Subject Property has ceased to operate as an ongoing manufacturing facility and nearly all physical structures have been removed from the site and as the site will be vacant and underutilized now that demolition work is concluding this calendar year;

WHEREAS, FuFeng USA Incorporated ("the Company") is an Illinois corporation headquartered in Oak Brook, Illinois, and is a subsidiary of FuFeng Group, is a publicly traded company listed on the Hong Kong Stock Exchange and employs over 15,000 people worldwide;

WHEREAS, the Company has proposed to purchase the Subject Property and develop the same as a corn wet milling and biofermentation facility (the "Facility") to process local corn into amino acids for animal feed markets (collectively "the Project");

WHEREAS, the County of Douglas, Tuscola Community Unit School District No. 301, Garrett Township, Garrett Township Highway Commissioner, Tuscola Township, Tuscola Township Highway Commissioner, Parkland College, and Douglas County Museum District (the "Taxing Bodies") are public agencies and taxing districts duly organized and existing under the laws and Constitution of the State of Illinois;

WHEREAS, the County Clerk of Douglas County, Illinois (the "County Clerk") is the local official responsible for extending taxes based upon assessments made against real property in Douglas County, Illinois;

WHEREAS, Section 10 of Article VII of the Constitution of the State of Illinois and the Intergovernmental Cooperation Act (5 ILCS 220/1, et seq.) provide authority for the Taxing Bodies to obtain or share services and to exercise, combine or transfer any power or function not prohibited by law or ordinance;

WHEREAS, the Taxing Bodies deem it necessary, useful and desirable to establish the future tax obligations of the Company with respect to the Subject Property; and,

WHEREAS, the Company and the Taxing Bodies desire to set out in writing their agreement regarding the scope of the Project, the amount of the Company's investment, and the future tax obligations relating to the Subject Property.

NOW, THEREFORE, in consideration of the matters set forth above, the mutual agreements made and contained in this Agreement, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the undersigned parties agree as follows:

<u>Section 1.</u> <u>Recitals.</u> The recitals of this Agreement are hereby incorporated and made a part of this Agreement as though fully set forth herein.

<u>Section 2.</u> <u>Project Definition.</u> "Phase I" shall be defined as including all of the following:

- (a) the purchase of the Subject Property by the Company;
- (b) the completion of construction of the Facility;
- (c) commissioning of the Facility;
- (d) all property improvements made upon the Subject Property by the Company in the initial years of construction of the Facility in 2025, 2026, and 2027.

Any improvements made after December 31, 2027, will be considered Phase II and are not subject to this Agreement. Nothing in this Agreement limits the

parties from negotiating a similar agreement with respect to Phase II or any potential future phases.

## Section 3. Real Estate Taxes.

- (a) In order to establish a value of the Subject Property for purposes of calculating real estate taxes under this Agreement, a Market Value Estimate for the Subject Property was commissioned by the Douglas County Supervisor of Assessments and conducted by Vanguard Appraisals in 2024 (the "Market Value Estimate"). A copy of the Market Value Estimate is attached hereto as Exhibit A and fully incorporated herein by reference. The parties accept the Market Value Estimate as setting the market values for purposes of this Agreement and stipulate that, upon completion of Phase I, the market value of the Land will be Eight Million Five Hundred Eighty Thousand Six Hundred and Twenty Dollars (\$8,580,620) and the market value of the Improvements planned for Phase I will be Two Hundred Forty-Two Million One Hundred Thirty-Five Thousand Eight Hundred and Seventy-Two Dollars (\$242,135,872).
- (b) For the 2025, 2026, and 2027 tax years, the actual taxable value of the Subject Property fixed for assessment purposes shall be Five Hundred Twelve Thousand Two Hundred Twenty-One Dollars (\$512,221.00).
- (c) For the 2028 tax year, the actual taxable value of the Subject Property fixed for assessment purposes shall be twenty-five percent (25%) of the Market Value Estimate of the Land, being Two Million One Hundred Forty Five Thousand One Hundred Fifty Five Dollars (\$2,145,155.00), PLUS twenty-five percent (25%) of the Market Value Estimate of the Improvements, being Sixty Million Five Hundred Thirty-Three Thousand Nine Hundred and Sixty-Eight Dollars (\$60,533,968).
- (d) Commencing with the 2029 tax year and ending with the 2057 tax year, the actual taxable value of the Subject Property fixed for assessment purposes shall be calculated by adding the actual taxable value of the Land, which shall remain twenty-five percent (25%) of the Market Value Estimate of the Land, being Two Million One Hundred Forty Five Thousand One Hundred Fifty Five Dollars (\$2,145,155.00), and the actual taxable value of the Improvements to the Subject Property fixed for assessment purposes, which shall be calculated by decreasing the previous year's actual taxable value of the Improvements by four percent (4%), as shown in Exhibit "B" which is attached hereto and incorporated fully herein by this reference.

(e) The County Clerk shall extend taxes against the Subject Property in the manner set forth on Exhibit "B" which is attached hereto and incorporated fully herein by this reference.

<u>Section 4.</u> <u>Conditions to Agreement</u>. The taxing structure set forth in this Agreement is contingent upon the following:

- (a) The Company shall purchase the Subject Property;
- (b) The Company shall employ no fewer than One Hundred Fifty (150) full-time employees by the commissioning date of the Facility;
- (c) The Company shall make a capital investment of Six Hundred Million Dollars (\$600,000,000) or more; and
- (d) The Company, for itself and on behalf of its affiliates, successors, and assigns, hereby irrevocably waives any and all rights to appeal tax assessments and tax amounts due for the Subject Property for the tax years covered by this Agreement.
- <u>Section 5</u>. <u>No Further Action Required</u>. The County Clerk acknowledges, agrees, and stipulates that no further action on behalf of the Taxing Districts is required to initiate and implement the taxing structure set forth herein, and the same shall be effective and applied each tax year as required by this Agreement.
- <u>Section 6.</u> <u>Default.</u> Except as otherwise expressly provided herein, if any party fails to comply with any material term, representation, warranty, covenant, agreement, or condition of this Agreement, and such failure to comply continues for a period of fifteen (15) days after the non-complying party's receipt of written notice thereof, such shall constitute an "Event of Default." No default by a party shall be actionable or be of other consequence unless and until it shall constitute an Event of Default.
- <u>Section 7.</u> <u>Remedies.</u> If there is an Event of Default, the non-defaulting parties shall have the right to seek all remedies available in law or equity, including without limitation, specific performance.
- <u>Section 8.</u> <u>Rights of Enforcement</u>. Each of the parties, individually or in concert with others, shall have the right and authority to exercise and enforce any and all provisions of this Agreement, and no party shall be obligated to seek the approval of other parties before taking action in its own name.

- <u>Section 9.</u> <u>Authority</u>. The parties represent to one another that they are each authorized to and have the power to enter into, and by proper action have duly authorized the execution, delivery and performance of this Agreement.
- Section 10. Notices and Communications. All notices, demands, requests for reimbursement, or other communications under or in respect of this Agreement shall be in writing and shall be deemed to have been given when the same are (i) deposited with the United States Postal Service via Certified Mail, postage prepaid; or (ii) sent by electronic transmission if receipt is confirmed by the receiving party; (iii) hand delivered, in each case, to the parties at their respective addresses (or at such other address as each may designate by notice to the other as set forth in this Section), as follows:

- <u>Section 11.</u> <u>Illinois Law.</u> This Agreement is made under and shall be constructed in accordance with and governed by the laws of the State of Illinois.

Jurisdiction and venue shall be proper only in the courts situated within the State of Illinois.

- <u>Section 12.</u> <u>Binding Effect.</u> The parties intend that the terms and conditions of this Agreement shall be a covenant running with the land and shall be binding upon and inure to the benefit of the parties hereto, their grantees, nominees, successors in interest, assignees, heirs, executors, or lessees. The parties agree that the tax structure set forth herein shall continue to be applied, irrespective of ownership of the Subject Property, so long as the terms and conditions of this Agreement are met.
- <u>Section 13.</u> <u>Rights Cumulative.</u> Unless expressly provided to the contrary in this Agreement, each and every one of the rights, remedies, and benefits provided hereunder shall be cumulative and shall not be exclusive of any other rights, remedies, and benefits allowed by law.
- <u>Section 14.</u> <u>Written Modification.</u> Neither this Agreement nor any provisions hereof may be changed, revised, modified, waived, discharged, terminated, or otherwise abrogated, diminished, or impaired other than by an instrument in writing duly authorized and executed by all the parties.
- <u>Section 15.</u> <u>Entire Agreement.</u> This Agreement contains the entire agreement and understanding of the parties with respect to the subject matter hereof, and supersedes all prior or contemporaneous negotiations, commitments, agreements, and writings, and all such other negotiations, commitments, agreements, and writings shall have no further force or effect, and the parties thereto shall have no further rights or obligations thereunder.
- <u>Section 16.</u> <u>Counterparts.</u> This Agreement may be signed in any number of counterparts with the same effect as if the signatures thereto and hereto were upon the same instrument.
- <u>Section 17.</u> <u>Non-Waiver.</u> None of the parties hereto shall be under any obligation to exercise any of the rights granted to them in this Agreement. The failure of a party to exercise at any time any right granted to said party shall not be deemed or construed to be a waiver of that right, nor shall the failure void or affect such party's right to enforce that right or any other right.
- <u>Section 18.</u> <u>Severability.</u> It is hereby expressed to be the intent of the parties that should any provision, covenant, agreement, or portion of this Agreement or its application to any person or property be held invalid by a court of competent jurisdiction, the remaining provisions of this Agreement and the validity, enforceability, and application to any person or property shall not be impaired thereby; but the remaining provisions shall be interpreted, applied, and

enforced so as to achieve, as near as may be, the purpose and intent of this Agreement to the greatest extent permitted by applicable law.

<u>Section 19.</u> <u>Interpretation.</u> This Agreement shall be construed without regard to the identity of the party who drafted the various provisions. Moreover, each and every provision of this Agreement shall be construed as though all parties to this Agreement participated equally in the drafting.

<u>Section 20.</u> <u>Third-Party Beneficiaries.</u> Nothing in this Agreement is intended, nor shall it be interpreted, to create any rights or remedies to and in any third party. No claim as a third-party beneficiary under this Agreement by any person shall be made, or be valid, against the parties.

Section 21. Personal Liability. No covenant or agreement contained in this Agreement shall be deemed to be the agreement of any official, officer, partner, member, director, agent, employee, planning consultant or attorney of any of the parties, in his or her individual capacity, and no official, officer, partner, member, director, agent, employee, planning consultant or attorney of any of the parties shall be liable personally under this Agreement or be subject to any personal liability or accountability by reason of, in connection with, or arising out of the execution, delivery, and performance of this Agreement, or any failure in connection therewith.

## POLICY 3.49 ACADEMIC CALENDAR BUILDING OF PROCEDURES

The Vice President for Academic Services is responsible for creating an academic calendar that meets all requirements of ICCB, aligns as much as possible with the calendar of the University of Illinois, and falls within the guidelines of the PAE contract in terms of the number of faculty working days. College closings and holidays will align with those established by the administration and the office of Human Resources as well as state and federal law.

## **Procedure**

- 1. The Vice President creates the academic calendar using the following basic assumptions:
  - <u>a.</u> 1. To receive state apportionment, community college semesters must have a minimum of 75 instructional days (excluding final exams and orientation days).
  - <u>b.</u> 2. Since many UIUC students concurrently enroll at Parkland each year, we must have compatible terms. The semesters schedules will be compatible with UIUC to accommodate university concurrently enrolled students at Parkland.

<u>c.</u> 3. The instructional academic calendar must be within will align with the guidelines of the PAE contract in terms of the number of faculty working days in the fall and spring semesters.

#### **Basic Elements**

- 1.-2. Basic\_Ffall and spring semester terms will each include contain at least 75 elass instructional days, (allows for two emergency or additional instructional or reading days), no more than 5 days for final exams, and no more than 5 days for of orientation a preparatory week. Each academic calendar will include one College-wide Professional Development Day. The following holidays are regularly observed: Labor Day, Thanksgiving—beginning at 5:00 p.m. the evening before and the Friday after, and Martin Luther King, Jr. Birthday. Spring break coincides with UIUC and includes a Saturday through Sunday nine-day period.
- 2. Summer session begins on the Monday following spring commencement. Memorial Day is observed. This coincides with UIUC Term I. Three credit hour classes usually contain 13 days of instruction and 1 day for final exams; four credit hour classes usually contain 18 days of instruction and 1 day for final exams.
- 3.3. On-campus instruction is not usually typically held on the eight Fridays of the six-and eight-week during the summer session. Exceptions require Vice President for Academic Services or designee approval.

## **Basic Process**

- 1. In September, the Vice President for Academic Services accesses the UIUC calendar online and, if necessary, contacts the UIUC Associate Director of Admissions and Records, who is a permanent member of the UIUC calendar committee, to determine what UIUC calendar is most likely two years in the future. (UIUC has a uniform procedure to determine key dates in their terms that involves counting days from key annual calendar dates.)
- 2. The Vice President for Academic Services then uses the above to build the first draft of the Parkland calendar.
- a. In Spring semester, check that Professional Development Day is on a Thursday. (The smallest number of scheduled day classes is on Thursday.)
  - b. The summer session begins on the Monday following commencement.
- 4. 3. The Vice President for Academic Services takes presents the first draft of the calendar, at least two years in advance, to the PCA Senate, and then to the College Council for review prior to approval by the Board of Trustees.
- 4. This calendar is then presented to the PCA Executive Council and Senate for review.

## **B.** Policy Information

1. Policy title: **Determination of Student Location** 

This is a proposal for a new policy that outlines the policy and procedure for determining the location of prospective students and enrolled students. This policy proposal is in response to the federal regulations (34 CFR 668.43) that require institutions to identify the location of their prospective and enrolled students and notify them if their current curriculum meets licensure requirements in their state. This policy is separate from the residency policy and is not intended to determine the residency classification of students. These new regulations add conditions to the Department of Education's Program Participation Agreement (PPA) which is an agreement between the Department of Education and an institution of higher education that participates in Title IV programs.

## **Chapter 8 8.33**

**8.33 Policy:** The policy determines the state in which a student is located as required by 34 CFR 668.43. The policy applies to prospective and enrolled students and is not intended to determine residency classification of students for the purpose of tuition and fee assessment. For this policy, prospective students are defined as students who have applied for admission and have not yet enrolled. Students who have registered for at least one class will be considered as enrolled students.

#### 8.33.01 General Procedure:

Student location is determined based on the permanent address in the Student Information System (SIS). For prospective and enrolled students, this is the state they live in based on the information provided on the application for admission, unless a change of address request has been submitted after the application for admission has been submitted. For students whose permanent address does not include a U.S. state or territory, their location will be the State of Illinois. Student Location designations shall remain in effect unless and until a student changes the U.S. state or territory listed in their permanent address using the Change of Address form. Once a student changes their permanent address to a different U.S. state or territory, Parkland College will consider the new U.S. state or territory as the student's location for the purposes of this policy.

#### 8.33.02 Direct Disclosures

Parkland College will communicate via email to students who have a permanent address outside of the state of Illinois and are seeking enrollment into a program of study in which the curriculum leads to a state licensure or certification. The disclosure is meant to provide information on whether the program's curriculum meets or does not meet educational requirement for licensure or certification in which the student permanently resides. Students are also encouraged to contact the appropriate licensing agency to seek information and additional guidance before beginning a program outside of their state. Additional licensure requirements may be necessary, such as professional examinations, background checks, years of work experience, fingerprinting, etc.

## 8.33.03 Attestations

Students attempting to enroll in a licensure program who have a permanent address in a location where the program does not meet licensure requirements may not enroll in the program without first completing and submitting the Attestation Form. The Attestation Form will be stored in the student record.
