Purpose

The purpose of these specifications is to support the towing requirements and support staff travel of the fifth-wheel career engagement trailer.

General

These are the specifications for a truck to meet the towing capacity and needs of the college. Bidders must answer all questions. Any unanswered questions will be considered noncompliant and nonresponsive and subject to rejection.
