RE: Freedom of Information Act Request

Mr. Dial:

This is to acknowledge that Parkland College District No. 505 is in receipt of your *Freedom of Information Act* (FOIA) request received in my office on May 19, 2021 via US mail. As the Vice President for Communications and External Affairs, I am responsible for processing requests for public information for the College, pursuant to *the Illinois Freedom of Information Act*, 5 ILCS 140/1 et seq. In your letter you requested the following items pertaining to the Parkland College Exterior Renovations Project:

1. The name, address and phone number(s) for the general contractor.
2. A complete list of all sub-contractors and contact information for each sub-contractor.
3. Any board meeting minutes pertaining to the above project for the past twelve (12) months.
4. The call for bids specifying State Prevailing Wage requirements.
5. Bid tabulations from the public bid opening including all bidders and their respective bids for the above project.
6. Copy of the general contractor and all sub-contractors proof of insurance; bond and Federal tax identification number.
7. Copy of the general contractor and all sub-contractors registered apprenticeship training program with the United States Department of Labor Bureau Apprenticeship and training.
8. Copy of the general contractor and all sub-contractors substance abuse prevention program per the Substance Abuse Prevention on Public Works Act 095-635.
9. Any supporting documents that will testify as to the General Contractor for being considered a responsible bidder.
