

Executive Summary

During Fiscal Year 2018, many state-supported grant programs at Parkland were fully funded for the first time in a number of years due to a resolution of Illinois' budget crisis. The return of these funds, in addition to receiving another Parkland-led National Science Foundation (NSF) grant and securing multiple incentive dollars from Ameren Illinois, provided the foundation for another strong year in the grants office.

Over the past few years, we have had to face the prevailing question regarding the level of funding available from Illinois for Parkland's state-supported projects. Thankfully, the resolution of the state's budget impasse made more than \$1 million available to the college in grant awards. These include multiple projects in adult education as well as support for Perkins funding and Parkland's Highway Construction Careers Training Program.

Another high point of the year for the grants office and Parkland in general was an award from the National Science Foundation (NSF) for an Advanced Technology Education (ATE) grant. This NSF-ATE grant for the development of Unmanned Aircraft Systems (UAS) curriculum is Parkland's second award through the ATE program. The UAS Curriculum for Industry Demand (U-CID) project fits well with Parkland's existing precision agriculture ATE grant and should provide the foundation for further applications for federal grant support.

Parkland's involvement with energy-related grants, incentives, and rebates continued to grow in 2017-2018 with more than 10 programs applied for or received. The majority of these projects are funded through Ameren Illinois who recently took over Illinois' energy efficiency funding portfolio from the Department of Commerce and Economic Opportunity (DCEO). In total, these applications have the potential to bring over \$200,000 into the college over the next few years in addition to the costs savings realized through the energy efficiency gains.

In addition to securing external funds, the grants office also looked internally and completed a campus-wide survey of 245 Parkland employees. The survey's aim was to understand the college community's knowledge of the grants office and the resources we offer as well as to identify strategies to increase our engagement with Parkland employees. In general, the survey indicated that we have made gains over the past few years in working to build the college's understanding of grant opportunities. It did, however, reveal a need to further reach out to faculty members with the resources and opportunities available through the grants office.


We continue to track our key metrics including number of applications submitted, funds secured, funding success rates, and employees working on grants. These metrics indicate another solid year as we submitted 35 applications compared to our 5-year average of 36.4; had a success rate of 85.7% compared to our 5-year average of 75.4%; and secured \$4,797,139 compared to our five year average of \$4,458,489.








Total Grant Funding by Fiscal Year


Grants Survey Results Summary

In FY18, the grants office conducted a survey to gather data regarding Parkland employees' awareness and opinions of the grants office. We then compared these results to a similar survey conducted in the 2013 fiscal year. Using this comparative data, we hope to continually improve our office functions and increase the awareness of the office's resources throughout the college.


For the FY18 survey, we collected responses from 245 participants compared to 184 in FY13; the breakdown of those participants can be seen in Chart A. The respondents from the FY18 survey had less experience at Parkland compared to the survey group from FY13; only 63% of FY18 respondents had 6+ years of service at Parkland compared to 73% in FY13.

Given the greater number of newer employees in the FY18 survey, it was not surprising to see that the FY18 group of respondents were less aware of the services provided by the grants office (Chart B) and therefore less likely to consider working on a grant (63% of FY18 respondents would consider applying for a grant compared to 68% in FY13).

Overall, a majority of employees are interested in applying for grants and have a good understanding of the role of the grants office. There were, however, a number of suggestions from the survey responses on ways to better engage Parkland employees. Chief

among these recommendations were making appearances at departmental and programmatic meetings during Welcome Back Week and hosting an event at the Center for Excellence. We plan to act on these suggestions and conduct a similar survey in the next 2-3 years.
