EXECUTIVE SUMMARY

The Year in Review

Despite a significant decrease in overall grant dollars available to community colleges due to the economy, Parkland diversified its funding sources in FY12 and maintained a steady stream of grant-generated revenue. There was a significant increase in the number of individuals at the college expressing interest in applying for grants. Faculty and staff applicants also represented an increasingly diverse range of departments.

In FY12, 49 grant applications were submitted to federal, state, and private funding sources. Of these applications, 30 resulted in new funding for the college. From July 1, 2011 to June 30, 2012, \$3.2 million was received from competitive grants and entitlements. Of this amount, \$2.7 million was awarded by the State of Illinois. Awards from the federal government totaled \$272,935, and \$213,912 was received from other sources.

Sources of grant funds are becoming more diversified, with state and private dollars replacing federal funding. Private sources, such as foundations and local agencies, are becoming the focus of more applications. Smaller grants, including those providing less than \$5,000 in funding and in some instances less than \$1,000, are having a significant impact on program viability and success. Programs and areas impacted include Community Education, the Parkland Art Gallery, the Parkland Child Development Center, and Adult Basic Education.

The college successfully competed for Illinois Community College Board (ICCB) funding for the 2013 Adult Basic Education program. Successful applications also included a \$90,000 grant from the Illinois Clean Energy Foundation to assist with the installation of a geothermal system for the new Applied Technology Center.

Several proposals were developed pertaining to international education opportunities. These included the U. S. Department of State Bureau of Educational and Cultural Affairs (ECA) Community College Initiative foreign exchange student program; U.S. Department of State ECA funding to support study abroad efforts in Costa Rica; the State Department's English Language Certificate Program supporting 25 Brazilian public school language teachers studying at Parkland next year; and the U.S. Embassy Islamabad Public Affairs Section Grants Program that will allow best practices in community college instruction to be shared with educators from IBA Sukkur, a community college in Pakistan.

Illinois Community College Board Highway Construction Careers

This grant trains up to 45 students a year to prepare them to enter into an apprenticeship with any of the trade unions in the state of Illinois. The goal of the grant is to increase the number of minority, women, and disadvantaged individuals on Illinois Department of Transportation construction projects.

Illinois Department of Agriculture

Sustainable Agriculture Grant Program

The \$14,633 award from The Illinois Department of Agriculture is being used to develop and manage an education and outreach project at Parkland's sustainable farm. The project focuses on demonstrating sustainable farming techniques to control weed development and soil erosion while also increasing crop yields.

Illinois Department of Commerce and Economic Opportunity Eliminate the Digital Divide

The Department of Commerce and Economic Opportunity through its Digital Divide program has provided \$103,500 (FY 2010- FY 2013) in funding that supports access to digital technologies. The grant has provided free basic computer education for over 800 individuals.

Illinois State Board of Education

Facilitating Coordination in Agriculture Education (FCAE)

The FCAE program provides agricultural students, teachers, and administrators in Illinois with the tools and technology to promote excellent agricultural education. The \$1,090,000 award from the Illinois State Board of Education allows the program to be staffed and fulfill its key activities of providing local program support, curriculum development resources, professional development, and on-site technical assistance throughout the state.









Purpose of Grant: This program supports research, education, and/or on-farm demonstration projects that address issues outlined in the Sustainable Agriculture Act.

Project: \$14,633

This project is doing the following:

- Identifying agricultural practices which maintain productivity and minimize environmental degradation.
- Testing and refining alternative approaches to organizing and conducting on-farm demonstration projects.
- Testing the usefulness of the existing conservation tillage knowledge base in making tillage system selection, implementation, and management decisions.
- Identifying the most critical needs for educational programs related to sustainable agriculture.

Impact:

The Illinois Department of Agriculture has provided \$14,633 to develop and manage an education and outreach project at Parkland's sustainable farm. The project focuses on demonstrating sustainable farming techniques to control weed development and soil erosion while also increasing crop yields.

ILLINOIS DEPARTMENT OF COMMERCE AND ECONOMIC OPPORTUNITY

Eliminate the Digital Divide

Contact: Tawanna Nickens. Adult Basic Education

Purpose of Grant: The Eliminate the Digital Divide program seeks to provide access to computers, tele-communications technologies, and related training to disadvantaged communities. DCEO awards grants to plan, establish, administer, and expand Community Technology Centers and to support basic computer literacy training programs.

Project: Funds from this grant will be used to support Community Technology Centers at Parkland on Mattis, the Champaign Public Library, and the Urbana Free Library. These Centers serve primarily unemployed or underemployed individuals by providing access to digital technologies and free basic computer instruction.

Facilitating Coordination in Agriculture Education (FCAE)

Purpose of Grant: Facilitating Coordination in Agricultural Education (FCAE) is a state project administered through the Illinois State Board of Education in cooperation with the Illinois Committee for Agricultural Education (ICAE). FCAE addresses the aims of Public Act 84-1452 involving the implementation of identified goals for improving education in and about agriculture in Illinois.

Project: \$1,090,000

FCAE is a statewide project that implements the "Strategic Plan for Illinois Agricultural Education— Opportunities for All Students Through Quality Agricultural Education." Parkland serves as the fiscal agent for the project.

Impact:

The FCAE program provides agricultural students, teachers, and administrators in Illinois with the tools and technology to promote excellent agricultural education. The \$1,090,000 award from the Illinois State Board of Education allows the program to be staffed and fulfill its key activities of providing local program support, curriculum development resources, professional development, and on-site technical assistance throughout the state.

ILLINOIS STATE BOARD OF EDUCATION

Illinois 21st Century Community Learning Centers Program

Contact: Pam Lau, Academic Services

Purpose of Grant: This program supports the creation of community learning centers that provide academic enrichment opportunities and social/emotional support during non-school hours for Latino and other students who attend high-poverty and low-performing schools.

Project: \$ 10,000 (Parkland request)

Parkland College is partnering with Urbana School District 116 and Leal Elementary School to help elementary and 9th-11th grade students meet state and local student standards in core academic subjects, pursue academic excellence through participation in career research and assessment, and grow academically and emotionally through positive mentorship opportunities.

Impact:

Funding from the Illinois State Board of Education, Illinois 21st Century Community Learning Centers Program will support extended day programs at Urbana High School and Leal Elementary School to assist low income and Latino students to succeed academically.

Project: \$112,943

The Parkland College migrant program provides itinerant services for pockets of migrants throughout District 505. There is an academic focus for students Pre-K to 12th grade with a particular emphasis on math, reading, and writing. Support services are provided for students Pre-K to 12th, with special attention placed on out-of-school youth.

Impact:

Funds are used to provide summer educational services and instructional supplies for migrant children and their families. The grant funding also provides staff professional development and recruitment services.

Adult Literacy Grant Program

Purpose of Grant: The TKF Foundation offers planning grant support for cross-disciplinary teams to develop proposals for integrated design and research studies to understand the impact of contemplative green space on urban dwellers. Partnering with Parkland on this project were the First Baptist Church of Waukegan, the Lake County Forest Preserve District, Chicago Wilderness, and the Landscape and Human Health Laboratory at the University of Illinois.

Project: \$42,198

The goal of the project team is to create a contemplative garden sited at the First Baptist Church in Waukegan Illinois.

Impact:

Funding from the TKF foundation allowed Parkland College and various project partners to design and plan for a sacred space in Waukegan, IL. Through this \$42,198 award, Parkland students were able to observe the planning and design process of a project. The award also positions the team to receive a second round of funding which will be used to construct the site and conduct research on site utilization, as well as provide field trips for Parkland students to participate.
