Mission

The mission of Grants and Contracts is to help college personnel obtain funding for projects that will benefit the Parkland College community.

Executive Summary

Parkland Grants and Contracts (G&C) experienced many changes and transitions during the 2014 fiscal year. The office was reduced in staff by one part-time worker and one administrator, a new grants assistant was hired, the grant writer transitioned to a program manager position, and the office was added to Parkland Institutional Accountability and Research. Although these changes disrupted the normal functioning of G&C, it presented an opportunity to refocus efforts and improve effectiveness.

Even with these transitions, G&C was still able to serve the Parkland Community by helping to bring in \$3,382,357 of external funding through 24 projects; this represents a 15.9% increase over the \$2,919,173 awarded in FY13. Federal funding continues to be scarce due to less availability of federal money and more colleges competing for awards. Though we received no direct federal funding in FY14, we do have two large federal Department of Education grants (Title III and CCAMPIS) still pending and expect to be competitive on a number of projects in FY15 through the Department of Labor (TAACCCT) and Department of Education (TRiO-SSS and Title VI). The majority of our FY14 awards came through state grants. State awards provided substantial funds to units such as Adult Education and Business Training, and also included large rebates for various "green" construction projects and initiatives around campus.

During the 2014 fiscal year, G&C worked to increase its involvement in consortium applications and collaborations with various institutions and community partners. As a result, Parkland was a part of three separate Trade Adjustment Assistance Community College Career Training (TAACCT) grant consortia and partnered with UIUC and Joliet Junior College on separate federal international education projects. We also targeted faculty/staff who had never before participated in a grant project at Parkland and as a result had multiple "first-time" individuals work on international education; health professions; and engineering, science, and technology projects.

For the 2015 fiscal year, we are looking forward to continually refining our processes and increasing the impact we have on the college. We plan to continue our efforts to reach out to new staff/faculty as well as participate in more consortium applications with other colleges and organizations. We also plan to increase our focus on non-governmental grants as state and federal funding continue to decrease and become more competitive. Though the grants landscape is continually shifting, we feel that our new strategies and initiatives leave us well positioned for the upcoming year.


Alignment with Strategic Plan for Excellence

How Grants & Contracts Utilizes the Strategic Plan for Excellence

For FY14, the Grants office tracked how each grant aligned to the goals of Parkland College's 2012-2017 Strategic Plan for Excellence (SPE). With the exception of Goal C, every goal was represented; Goal C wasn't represented because it was specific to the construction of the new Student Services Center, and to remodeling and repurposing existing spaces.

Goals A, B, and D, however, can be directly addressed through grant funding. The intent of aligning grant programs to Parkland's SPE goals is to ensure that the grants applied for through our office support the overall mission and goals of the college. Note that some grants align with multiple SPEs, so the total number of SPEs will not match the total number of funded grants.








Sustainability Grant Trends FY12—FY14


Over recent years, a new source of external funding for Parkland College has come from rebates associated with sustainability, energy efficiency, and "green" projects. These rebates are mostly provided through the Illinois Clean Energy Community Foundation, Illinois Green Economy Network (IGEN), and the Illinois Department of Commerce and Economic Opportunity (DCEO). Green projects at Parkland receiving rebates over the last three years include the installation of geothermal wells, photovoltaic solar panels, occupancy sensors, and energy efficient lighting. The college has also received rebates for the design and construction of the ATC and Student Union buildings.

The charts below show the gradual increase in the number of rebates over the past three years as well as the total award amount. We expect the number of rebates received to continue to increase in FY15 and believe the total amount awarded will also go up (the award amount is more variable due to fluctuating incentive amounts). In general, these rebates represent a new source of funding that can be reinvested in other "green" projects which provide additional savings through other rebates and reduced energy usage; for example, a portion of rebate dollars from the ATC building construction were used to help purchase a solar panel unit.





Dollars Awarded for Sustainability Grants FY12—FY14







Grants Office Performance

Applicant Survey

In a continuous effort to improve our services, Parkland Grants and Contracts (G&C) distributes a survey to each grant applicant. While our respondent number for FY14 was relatively low, the feedback was highly positive for each respondent, as is reflected in the tables below. Since G&C works with many of the same Parkland employees on a consistent basis, our presumption is that those who completed a survey in FY13 chose not to respond in FY14 (we hope to improve the response rate for FY15). Although positive, the survey responses over the past two years have indicated a lack of awareness of the services we offer and how the grant process works. Therefore, in FY15 we will work to increase our web presence, utilize networking opportunities, and update and distribute our Grants Handbook in order to clearly outline Grants office services and procedures.
