

Executive Summary

As has been the norm over the last few years, Parkland's Grants and Contracts office experienced a number of changes during this past fiscal year. One major change occurred in late autumn when our office was moved to the new Student Union. Changing office locations proved to be an ideal time to reevaluate and reorganize multiple processes and protocols including updating our internal webpage, creating an external webpage, rewriting the grants handbook, and creating a flowchart of grants processes. FY15 was also the first time in many years that our staffing structure stayed consistent for the entire year, which offered welcomed consistency and stability, and allowed us to focus more on long-term planning and larger projects. Finally, the restructuring of many administrative positions at the college held up some planned activities, but should open up new opportunities in the coming years.

Compared to FY14, we increased the number of grants submitted, grants received, total dollars awarded, and overall success rate. The total dollars awarded spiked significantly compared to last year due to Parkland being awarded a \$2.1 million Title III grant from the Department of Education that had been submitted in FY13. We also completely met 12 of the 19 measurable objectives we identified at the beginning of the year and partially met an additional 5 objectives. Furthermore, we made progress on three long-term goals: increased collaboration with the Parkland Foundation; increased collaboration with UIUC and other 4-year institutions; and increased faculty/staff involvement with grants.

Much like last year, the climate for grants, rebates, and other sponsored programs throughout Illinois and across the country continues to be challenging. Funding opportunities continue to diminish (especially at the state level) and the number of colleges and non-profits applying for funds is greater than ever. This past year also saw the state of Illinois freeze funding on a number of grants and rebates (including several projects involving Parkland), and it is unknown if or when funding will be restored.

As a result of the uncertainty for community colleges concerning government grants, we are focused on continuing to strengthen our relationships with regional 4-year institutions as well as with other community colleges. Consortium applications have been a growing focus of many grantors and these partnerships strengthen our competitiveness through leveraging multi-institutional resources. We also plan to work with the Parkland Foundation to identify funding needs at the college that might be met by individual donors or corporate sponsorships. Through these strategies, we hope to continue to receive and support our existing projects while also expanding our award portfolio into new areas and opportunities.










5-Year Grant Award Reporting Comparison

Each year, Grants and Contracts reports the total award amount for any grant received in that fiscal year; however, reporting the full award amount for a multi-year grant tends to skew the overall grant funding trends at Parkland. Dividing the award amount of a multi-year grant by the number of years of that grant and showing the prorated amount for each year provides a more balanced and accurate picture of grant dollars coming into Parkland. The charts below demonstrate the difference between reporting the total awards received in a fiscal year versus reporting the prorated amount.
